**Assumption of Risk**

I am aware that participating in the sport of triathlon and any Saskatchewan Triathlon Association Corporation (STAC) sanctioned event has many inherent risks, including but not limited to: drowning, electrocution, being hit by a boat, breaking of limbs, bicycling crashes, car crashes, saddles sores, carpal tunnel syndrome, repetitive strain injuries, bee stings, food poisoning, allergic reactions, animal bites, insect bites, blisters, sunburn, dehydration. I freely accept and fully assume all such risks, dangers and hazards and the possibility of personal injury, death, property damage or loss, resulting there from.

**Release of Liability, Waiver of Claims & Indemnity Agreement**

In consideration of The Organizers of any STAC sanctioned event of allowing my participation in any STAC sanctioned event, I agree as follows:

1. To waive any and all claims that I have or may have in the future against The Organizers of any STAC sanctioned event and its members, officers, employees, students, agents, sanctioning organization, volunteers and independent contractors (all of whom are hereinafter collectively referred to as "the Releasees");
2. To release the Releasees from any and all liability for any loss, damage, injury or expense that I may suffer, or that my next of kin may suffer as a result of my participation in the sport of triathlon and any STAC sanctioned event due to any cause whatsoever INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER THE OCCUPIERS' LIABILITY ACT, RSA 1980 c.0-3 AS AMENDED ON THE PART OF THE RELEASEES;
3. To hold harmless and indemnify the Releasees from any and all liability for any damage to the property of, personal injury to, any third party, resulting from my participation in the sport of triathlon and any STAC sanctioned event;
4. This agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns and representatives in the event of my death or incapacity. In entering into this Agreement, I am not relying upon any oral or written representatives or statements made by the Releasees other than what is set forth in this Agreement; and
5. I realize that, with this membership, I may be subject to unannounced drug testing as provided for by Triathlon Canada's agreement with the Canadian Centre for Ethics in Sport.
6. Day of Event membership extends to sanctioned event activities for the day of the event only and are not available for adults.
7. To grant full permission to the Sask. Triathlon Association Corp. to use event photographs and video images I appear in for STAC promotional purposes.

I have read and understood this Agreement and I am aware that by signing this Agreement, I am waiving certain legal rights which I or my heirs, next of kin, executors, administrators and assigns may have against the Releasees.
